LIHTC Year 15 Training and Buyers & Sellers Conference

The CCAH-sponsored *LIHTC Year 15 Training* was held on July 28, in Charlotte at the Renaissance Hotel. Attended by more than 50 people, the training was very well received. Trainers were Tim Smith, Rhonda Skiles and Erica Vernon, CPAs and partners in Bernard Robinson & Company, LLP. Also participating in providing attendees with important property tax information was Craig Cardella, Partner and Managing Director of Property Tax Eagle, a company that assists owners in property tax abatement.

The following day at the Renaissance Hotel, a *Buyers and Sellers Conference* was jointly hosted by CCAH and USDA National Office. Eleven states were invited to participate. With about 90 people attending, nearly half were buyers. A welcome address by Bryan Hooper, USDA Multi-Family Deputy Administrator, stressed the importance of preserving the existing portfolio of multifamily housing. The morning program consisted of a financing panel moderated by Frankie Pendergraph. There were five lenders active in financing multifamily properties represented on the panel. In addition, USDA presented a panel of three underwriters—Martha Hanson, Beverly Casey, and Tim Chandler—who discussed the USDA program transfer requirements and the new underwriting tool that is now in use. The conference adjourned at noon for lunch, while interested parties made appointments to meet privately with State Program Directors, one of the USDA underwriters, or with someone from the USDA National Office in the afternoon.
